

What is the Gatehouse Summer School Bursary?

The Gatehouse Youth Theatre Bursary fund provides financial support to help young people overcome specific barriers to allow for their participation. It exists to enable participants to take part in our Summer School project that otherwise would not be able to.

What can I expect financial support with?

There are two bursaries available. Bursary A which covers 50% of the costs and Bursary B which covers 100% of the costs.

Who is the GSS Bursary Fund for?

To be eligible you must be facing financial hardship preventing your children from participating in our Summer School project. While anyone is free to apply for the bursary fund to help support participation, priority will be given to those:

- In care
- Care leavers
- You/parents/carer in receipt of Income Support, or Universal Credit in place of Income Support, in their own right
- You/parents/carer in receipt of Employment and Support Allowance or Universal Credit and Disability Living or Personal Independence Payments in their own right
- In receipt of Free School Meals
- Young Carers

How is my application reviewed and when will I find out?

Applications are reviewed by members of our senior management team. Every application is highly confidential and the information you provide will not be shared with any unauthorised staff member.
